## Accredited Estate Planner® (AEP®) Designation Core Value

Awarded by NAEPC to estate planning professionals who meet requirements of education, experience, knowledge, professional reputation, and character. All applicants must agree to continuously abide by the NAEPC Code of Ethics, must acknowledge the highly complex, multi-disciplinary nature of estate planning, and must commit to the core value of collaboration and the team concept in their approach to client relationships by signing the Applicant Declarations document as part of the application process.

## Accredited Estate Planner® Designation Qualifications & Requirements for All Applicants

- Active practice for a minimum of 5 years within the following disciplines: accounting; insurance/financial planning; law; philanthropy; or trust services
- Devoting at least 1/3 of one's professional time to estate planning
- Holding one or more of the following credentials in active status and good standing: CPA, CLU®, CFP®, CFA, ChFC®, CPWA®, CAP®\*, CSPG, CTFA, JD, MSFS, and MST\*\*
- Three professional references (unless council nominee)
- Current membership in an affiliated council

<sup>\*</sup> Applicants applying with CAP® only must take MSFP615 through The American College regardless of the years of experience

<sup>\*\*</sup> Applicants with MST as the qualifying credential must secure pre-approval from the national office before applying

# Accredited Estate Planner® (AEP®) Designation – Self-Nomination Program

• Two Pathways to Attainment through Self-Nomination (Application Fee is \$350 with 1<sup>st</sup> year dues of \$175)

#### Education

 Successful completion of 2 graduate courses through The American College of Financial Services or another accredited educational institution, business school, or school of law

### Experience\*

 With 15 years or more of experience in estate planning may opt out of the educational requirement

(\*Reduced to 10 years if nominated by the council and graduate coursework requirement is waived)

# Accredited Estate Planner® Designation Council Nomination Program History

- In 2004, the NAEPC board created the council nomination program in recognition of the fact that as council leaders you are in a unique position to know who in your council may be interested in the designation and qualified for a council nomination
- Accomplished by a Council Nomination Resolution signed by the current council president and one additional council officer, the council nomination process offers the candidate a more streamlined application process with a reduced application fee
- At the same time, the council benefits from the fact that membership in the council is required to maintain the designation in active status and good standing
- Your council's participation affirms the core value that brings all members of the NAEPC together – excellence in estate planning!

# Accredited Estate Planner® Council Nomination Program – How it differs from self-nomination

- Streamlined application process
- Council Nomination Resolution stands in for otherwise required 3 professional references
- Application fee is reduced by 50% (currently \$175)
- Minimum experience requirement is 10 years actively engaged in estate planning
- Graduate coursework is not required for council nominees
- Councils with less than 100 members, may nominate 1 qualified candidate in each of the 5 disciplines that we recognize accounting, insurance/financial planning, legal, philanthropy & trust plus 1 additional in any of the 5 disciplines for a total of 6 on an annual, calendar year basis; councils with 101 member or more may double the number of nominees

## Accredited Estate Planner® Designation Ongoing Requirements

Participation in annual recertification process to certify:

- Continuing engagement in estate planning activities
- Continuing commitment to NAEPC Code of Ethics and team concept of estate planning
- Continuing education requirement of 30 hours earned every 2 years with 15 hours in estate planning topics
- Maintaining all other professional designations in active status and good standing
- Continuing membership in an affiliated estate planning council
- Cooperation with random annual audit if selected
- Payment of annual dues to maintain designation currently \$175

# Accredited Estate Planner® (AEP®) Special Circumstances and Review Process for all Applications

- For applicants applying with the Chartered Advisor in Philanthropy® (CAP®) only, must take MSFP615 Advanced Estate Management and Planned Giving (formerly GS815 Advanced Estate Planning) through The American College of Financial Services regardless of years of experience; those with less than 15 years must take one of the following electives as well: MSFP 543 Business Succession Strategies (formerly GS 838 Business Succession Planning), MSFP 584 Executive Compensation (formerly GS 842) or MSFP 589 Financial Statements and Business Valuation Analysis (formerly GS 803).
- For applicants applying with MST degree as the qualifying credential, must secure pre-approval from national before submitting application.
- All applications regardless of pathway, are subject to a 2-part review process, the first of which is administrative where all documentation submitted with the application is reviewed and verified, followed by a comprehensive review by a national committee composed of members of the AEP® Designation Committee who also currently serve as national board members or past presidents of NAEPC.
